iConquerMS™ takes your privacy very seriously. This policy details the types of information we collect when you visit www.iConquerMS.org (referred to as 'this website'), and how that information may be used. By using this website, you indicate your acceptance of this policy.

He or she can elect to unsubscribe at any time, and his or her email will not be shared with any outside parties or used for any additional purposes without his or her consent.

Session Information

We might use web beacons or related technologies for the purpose of gaining information on how you access and navigate this website ("session information"). This session information may be used to improve the performance of this website, and/or your user experience, and/or to enhance recruitment.
